- 2 Proceedings on Estimates of Expenditure for FY2017/2018 – (Leader of the House) – Motion made, and Question put – Resolved, "That the proceedings on the Estimates of Expenditure for FY2017/2018 be taken till 9.00 pm on the days allotted to the Committee of Supply on the Estimates for FY2017/2018."
- 3 Budget Statement – (Minister for Finance) (3rd Allotted Day) – Question again proposed on resumption of Debate on Question (20 February 2017), "That Parliament approves the financial policy of the Government for the financial year 1st April 2017 to 31st March 2018." – Debate resumed.

- 4 Announcement by Speaker – Mdm Speaker made the following communication to the House:-
- "We have completed the debate on the Budget Statement. We are now going into the Committee of Supply to debate the estimates.
