QUESTIONS NOT FOR ORAL ANSWER

- 1. Mr. R. Jumabhoy: To ask the Chief Minister to state—
 - (a) the names of the experts and/or advisers who visited Singapore at the Government's invitation between May 1955 and 30th September 1958, giving their countries of origin, the type of work they did, with particulars of their remuneration, duration of stay and the sums of money spent on account of each of them;
 - (b) the particulars of the recommendations or reports submitted by them; and
 - (c) the actions taken by the Government to implement such recommendations or reports.
- 2. Mr. LEE CHOON ENG: To ask the Minister for Labour and Welfare—
 - (a) what are the total number of members and the total incomes of each of the Seamen's Unions mentioned below, as declared in their annual returns to the Registrar of Trade Unions for the periods ending 31st March in each of the years from 1956 to 1958:—

Chinese Seamen's Union (Singapore Branch);

National Chinese Seamen's Union;

Malay Seamen's Union of Singapore;

Malayan National Seamen's Union:

Pakistani Seamen's Union of Singapore;

Singapore Chinese Seafarers' Association;

Singapore Ship Workers Union:

National Seamen's Union of Pakistan;

Malaysian Mariners' Union;

All Races Seamen's Union; and

(b) on what dates did each of the Unions submit their returns.

- 3. Mr. Lee Choon Eng: To ask the Minister for Labour and Welfare to state the total number of Trade Unions affiliated to the Singapore Trades Union Congress, giving the total number of members of each Union and the income derived as affiliation fees from such affiliated Unions as shown in the annual returns submitted by the Congress to the Registrar of Trade Unions for the periods ending 31st March in each of the years from 1956 to 1958.
- 4. Mr. LEE CHOON ENG: To ask the Minister for Labour and Welfare—
 - (a) whether the Seamen's Council of Action is a registered organisation; and what are its aims and objects;
 - (b) whether the Council of Action is a federation of Seamen's Unions; and
 - (c) who are the President, Secretary and Treasurer of the Council of Action.
- 5. Mr. Lee Choon Eng: To ask the Minister for Labour and Welfare to state—
 - (a) the total number of Trade Unions registered in Singapore as at 30th June, 1958;
 - (b) how many of these Unions failed to submit to the Registrar of Trade Unions their annual returns for the year ending 31st March, 1958, on or before 30th June, 1958;
 - (c) how many of these Unions were served with notice as required under section 15 (1) (b) (v) of the Trade Unions Ordinance (Cap. 154) for not submitting their annual returns before 30th June, 1958, and the dates on which these Unions were served with such notice;
 - (d) how many Unions have not submitted their annual returns as at 30th September, 1958, and for what periods; and
 - (e) how many Secretaries of Unions have, to date, been prosecuted under section 44 (5) of the Trade Unions Ordinance, for failing to submit their returns and the results of such prosecutions.
- 6. Mr. LEE CHOON ENG: To ask the Minister for Commerce and Industry to state how many proprietors of Seamen's Lodging Houses were prosecuted between January, 1946, and 30th September, 1958, for—
 - (i) overcrowding the premises;
 - (ii) overcharging lodgers;
 - (iii) using the premises as brothels,
 - classifying the number of such proprietors by races.
- 7. Mr. LEE CHOON ENG: To ask the Minister for Commerce and Industry what are the charges for admission to the cinema shows at Connell House (European Seamen) and Asian Seamen's Club (Asian Seamen), and to state the reasons for any differences in such charges.
- 8. Mr. Seah Peng Chuan: To ask the Minister for Commerce and Industry whether, before legislation for incorporating the Seamen's Registry Board was introduced, his Ministry had approached the employers' organizations in the shipping industry and the Seamen's Unions to set up a body for the registration and engagement of seamen to be operated by them at their own expense; and what was the result of such an approach.

- 9. Mr. SEAH PENG CHUAN: To ask the Minister for Commerce and Industry to state, from the establishment of the Seamen's Registry Board to 30th September, 1958—
 - (i) the fees paid to the Chairman and each of the Members of the Board:
 - (ii) the income and expenditure (giving details) of the Board; and
 - (iii) the number of Seamen's Registration Cards issued by the Board.
