QUESTIONS FOR ORAL ANSWER

- *1. Mr. LIM CHER KHENG: To ask the Chief Secretary to state the latest approximate estimated number of persons in Singapore who are Hokkien, Cantonese, Teochew, Hakka, Hainanese and Foochew.
- *2. Mr. LIM CHER KHENG: To ask the Chief Secretary whether he is aware of the strong opposition of the various Chinese community associations and guilds of Singapore to the Government's decision to discontinue using the Teochew, Hakka, Hainanese and Foochew dialects in the local broadcast of the Chinese programme from January 1959, and whether the Government will reconsider this decision.
- *3. Mr. LIM CHER KHENG: To ask the Chief Secretary what progress has been made in the examination and exemption of the publications affected by the general ban on the publications of 53 publishers in Hongkong and China.
- *4. Mr. JOHN EDE: To ask the Minister for Health whether he will state—
 - (a) the total number of persons who have been X-rayed under the Government Tuberculosis Survey;
 - (b) what percentage of these persons showed evidence of tuberculosis, both healed and active;
 - (c) what percentage of these persons have been found to require active treatment; and
 - (d) whether there is a waiting list for the admission of infecting tuberculosis cases to hospital, including cases not discovered by the Survey.
- *5. Mr. John Ede: To ask the Minister for Health whether he will make a statement on what further measures the Government proposes to take in the campaign against tuberculosis in the light of the findings of the Government Tuberculosis Survey.
- *6. Mr. LIM CHER KHENG: To ask the Minister for Commerce and Industry to give the following particulars relating to cottons for the period from January to October 1958:—
 - (a) quantity imported into Singapore from each country and the countries from which they were imported; and
 - (b) quantity re-exported to each country and the countries to which they were re-exported.
- *7. Mr. LIM CHER KHENG: To ask the Minister for Commerce and Industry whether he will make a statement on the effects of the suspension by China, as reported in the local press, of the import of certain goods into Singapore, and what steps does he propose to take to ensure that the entrepôt trade of Singapore will not be jeopardised and that the cost of living in Singapore will not rise as a result of this suspension.

Importance of unrestricted Trade between Singapore and China.

OUESTIONS NOT FOR ORAL ANSWER

- 1. Mr. Lee Choon Eng: To ask the Minister for Labour and Welfare to state—
 - (a) the total number of registered Trade Unions in the Colony as at 31st March, 1957; the number and names of those Unions which failed to submit to the Registar of Trade Unions their annual returns for the year ending 31st March, 1957, by 31st March, 1958; and the actions (with dates) taken against them;
 - (b) the names of those registered Trade Unions which failed to submit their annual returns for the year ending 31st March, 1958, by 30th June, 1958; and the names of those Unions served with notices during the months of July and October, 1958, because of such failure, stating the duration of the notices; and
 - (c) the names of those registered Trade Unions which failed to submit their annual returns for the year ending 31st March, 1958, by 30th September, 1958.
- 2. Mr. Lee Choon Eng: To ask the Minister for Labour and Welfare to state—
 - (a) how many applications for registration as Trade Unions were refused between January 1948 and October 1958, and the grounds of refusal; and
 - (b) how many Trade Unions have had their certificates of registration cancelled by the Registrar of Trade Unions for not submitting their annual returns for the year ending 31st March, 1958, by 8th September, 1958.

- 3. Mr. SEAH PENG CHUAN: To ask the Chief Secretary whether he is aware of allegations that suspects rounded up by the Police are assaulted inside police vehicles en route to police stations, and if he will cause an investigation to be made into the matter.
- 4. Mr. SEAH PENG CHUAN: To ask the Financial Secretary, in view of the distress reported to have been experienced by an accused in a Traffic Court, when his payment of a fine exceeding two dollars in one cent coins was at first not accepted, if he will consider issuing instructions to revenue-collecting Government Departments to accommodate members of the public as far as possible.
- 5. Mr. SEAH PENG CHUAN: To ask the Minister for Health to state the names of the two persons referred to in paragraph 38 of the First Report from the Public Accounts Committee (Sessional Paper No. L.A. 17 of 1958), and what steps have been taken to date to recover the overpayments.
- 6. Mr. SEAH PENG CHUAN: To ask the Minister for Commerce and Industry if he is aware of any opposition by shipowners' organisations and seamen's unions to the compulsory medical examination required under the provisions of section 44 of the Merchant Shipping Ordinance (Cap. 207), and what action he has taken or proposes to take in the matter.
- 7. Mr. SEAH PENG CHUAN: To ask the Minister for Commerce and Industry whether—
 - (a) the Seamen's Registry Board, in supplying registered seamen to employers, discriminates against seamen who are members of unions;
 - (b) he will arrange for permission to be given for an official of the union to which a seaman belongs to be present when the seaman signs an "agreement with the crew"; and
 - (c) he will arrange for a copy of such agreement to be provided to the seaman concerned.
- 8. SEAH PENG CHUAN: To ask the Minister for Commerce and Industry whether he will consider lifting the ban on the import of cottons into Singapore from China.
- **9.** Mr. SEAH PENG CHUAN: To ask the Minister for Commerce and Industry whether he will permit a Trade Mission from Singapore to go to China to improve the trade relations between the two countries.
