### QUESTIONS FOR ORAL ANSWER

- \*1. **Mr. L. P. Rodrigo:** To ask the Minister for Education if the Educational Advisory Council has hitherto been an efficient source of advice on matters of educational policy and development.
- \*2. **Mr. L. P. Rodrigo:** To ask the Minister for Education (a) whether measures have been taken to assess the effectiveness of educational television as it is currently programmed to schools as a medium of instruction; and (b) whether there are plans to expand the department of educational television in the immediate future.
- \*3. **Mr. Ang Nam Piau:** To ask the Minister for Law and National Development (a) when work will commence to widen Upper Thomson Road between  $4\frac{3}{4}$  m.s. and  $6\frac{1}{2}$  m.s.; and (b) what measures he proposes to take to safeguard the interests of the residents and shop-keepers who will be directly affected by the project.
