OUESTIONS FOR ORAL ANSWER

- *1. Mr. A. P. Rajah: To ask the Prime Minister what is the estimated maximum and safe capacity, in millions of gallons per day, of the following sources of water supply to Singapore:—
 - (i) MacRitchie Reservoir;
 - (ii) Peirce and Seletar Reservoirs;
 - (iii) Gunong Pulai and Pontian; and
 - (iv) Tebrau River.
- *2. Mr. A. P. Rajah: To ask the Prime Minister whether the dry-weather flow in the Tebrau River is capable of supplying the additional quantity of water required for 1960.
- *3. Inche Mohd. Ali bin Alwi: To ask the Minister for National Development what is the total area of land on Singapore Island owned and/or occupied by Her Majesty's Navy, Army and Air Force.
- *4. Inche Mohd. Ali bin Alwi: To ask the Minister for Finance whether the personnel of the Guard and Escort Unit of the Singapore Police Force are on the permanent establishment.
- *5. Inche Mohd. Ali bin Alwi: To ask the Minister for Finance what is the policy of the Government with regard to persons with Malay Standard VII who seek entry into the Singapore Police Force and the Customs, Immigration and Postal Departments.
- *6. Inche Mohd. Ali bin Alwi: To ask the Minister for Culture whether the Government will seek representation on the "Romanised Spelling Committee" formed by the Governments of the Federation of Malaya and the Republic of Indonesia.
- *7. Inche Mohd. Ali bin Alwi: To ask the Minister for Home Affairs to state how many aliens became citizens of Singapore between 1st January and 15th December, 1959, and how many citizens of Singapore voluntarily renounced their Singapore citizenship during the same period.
