QUESTIONS FOR ORAL ANSWER

- *1. **Mr. Lim Cheng Lock:** To ask the Minister for Finance (a) what is the total amount paid to the Government from the proceeds of the Singapore Sweep since its inception; (b) from this sum, what are the amounts distributed respectively to each sports, welfare or other project or body; and (c) what advantage will be gained by Singapore Pools (Private) Limited taking over the conduct of the Singapore Sweep.
- *2. **Mr. N. Govindasamy:** To ask the Minister for Law and National Development if he will ascertain from the Housing and Development Board what is the total number of applicants on the waiting list, as at the latest convenient date, for the renting of (i) one-room flats; (ii) two-room flats; and (iii) three-room flats.
- *3. **Mr. N. Govindasamy:** To ask the Minister for Law and National Development if he will ascertain from the Housing and Development Board how many applicants for the purchase of the Board's flats have been registered under the "Home Ownership Scheme" up to the latest convenient date.
- *4. **Mr. N. Govindasamy:** To ask the Minister for Law and National Development if he will ascertain from the Housing and Development Board whether there is any difference between the purchase price of a flat that has been previously rented out and that of a similar newly completed flat.
- *5. **Mr. Ho Kah Leong:** To ask the Minister for Health if he will consider extending dental services to Government-aided schools.
- *6. **Mr. Ho Kah Leong:** To ask the Minister for Health when the second market in Jurong Town will be opened.
