QUESTIONS FOR ORAL ANSWER

- *1. Enche Abdul Aziz Karim: To ask the Minister for Finance whether the Department of Statistics will compile a list of prices of basic foodstuffs in the main markets in Singapore and make such information available to the public daily through radio, television and the press to keep the people informed of price trends so that they may avoid being overcharged by unscrupulous vendors.
- *2. Mr. N. Govindasamy: To ask the Minister for Finance why is the annual value of certain dwelling houses in a housing estate assessed at double that of other houses in the same estate where the houses are each of similar construction and size and owner-occupied.
- *3. Mr. Hwang Soo Jin: To ask the Minister for Finance what measures have been taken or are being taken to speed up the work at the Stamp Office in order to cope with the increased pressure on that Department as a direct result of the recent amendment to the Stamp Ordinance.
- *4. Mr. P. Selvadurai: To ask the Minister for Finance if he will consider introducing legislation similar to the Trade Description Act, 1968, of the United Kingdom.
- *5. Mr. Lee Teck Him: To ask the Minister for Finance if he will encourage the setting up of another iron and steel mill in Singapore.
- *6. Mr. Yeoh Ghim Seng: To ask the Minister for Finance if he will instruct officers of the Radio and Television Licencing Section to investigate complaints of the non-receipt of renewal forms by radio and television licence-holders; and if he will instruct those officers not to institute prosecutions in cases where the complaint is well founded and the licence-holder renews his licence at the first opportunity after expiry.
- ***7.** Mr. Tay Boon Too: To ask the Minister for Finance if he is aware that some Government quarters, for example, those in the Haig Road and Farrer Park areas, are old and are rented out to civil servants at uneconomic rents, and if he will consider pulling down such quarters and erecting multi-storey flats instead, so that more families of civil servants can be accommodated and more rents collected.

- ***8.** Mr. Lee Teck Him: To ask the Minister for Finance whether he will consider the levy of a national defence tax on capital investments by Singapore Citizens in commercial and industrial undertakings on the following scale:—
 - (a) 1 per cent on investments between \$100,000 and \$500,000;
 - (b) 2 per cent on investments between \$500,000 and \$1,000,000;
 - (c) 3 per cent on investments between \$1,000,000 and \$5,000,000; and
 - (d) 5 per cent on investments of \$5,000,000 and above;
 - and if he will introduce the necessary legislation.
- ***9.** Mr. Cheong Yuen Chee: To ask the Minister for Foreign Affairs and Minister for Labour what is the number of workers retrenched during each of the years 1966 to 1968, and what is the percentage of these numbers in the private sector.
- ***10.** Mr. Cheong Yuen Chee: To ask the Minister for Foreign Affairs and Minister for Labour whether the Government proposes to provide a retraining scheme for retrenched workers in the private sector similar to that offered to retrenched workers of the British military establishments.
- ***11.** Mr. Cheong Yuen Chee: To ask the Minister for Foreign Affairs and Minister for Labour what is the estimated cost for organising the retraining scheme for retrenched workers of the British military establishments; and what will be the estimated cost for providing similar facilities to retrenched workers in the private sector.
- *12. Mr. P. Selvadurai: To ask the Minister for Foreign Affairs and Minister for Labour (a) what is the number of foreigners who have been granted Singapore citizenship under the 5-year rule; (b) how many of them are employed by the Government and statutory bodies; (c) how many such persons have left the service of the Government or statutory bodies; and (d) what were the criteria adopted in granting Singapore citizenship under the 5-year rule.
- ***13.** Mr. Lee Teck Him: To ask the Minister for Education whether and when the Senior Cambridge Examination will be replaced by an examination to be conducted by a local examination board.
- *14. Mr. Tay Boon Too: To ask the Minister for Education (a) how many Nanyang University graduates have served as teachers in (i) Government Chinese secondary schools; (ii) Government-aided Chinese secondary schools; (iii) Integrated secondary schools; and (iv) other secondary schools up to the end of February, 1969; (b) how many of those teachers have been promoted to the post of principal; and (c) whether he will consider taking steps to enable more trained Nanyang graduate teachers to be appointed principals in the Chinese secondary schools.
- ***15.** Mr. Tay Boon Too: To ask the Minister for Education how many untrained teachers are at present serving as principals in primary schools

in the four language streams; and whether he will take steps to have them replaced by trained and qualified teachers.

- *16. Mr. P. Selvadurai: To ask the Minister for Education (a) how many Tamilmedium schools there are in Singapore; (b) where the teachers for those schools are recruited from; (c) what type of students attend those schools; (d) what are the quality and standard of education imparted to children in those schools; and (e) what are the future prospects in Singapore of children educated in those schools.
- *17. Mr. Teong Eng Siong: To ask the Minister for Education how many bursaries the Government intends to offer in 1969 to students in the University of Singapore, the Nanyang University, the Singapore Polytechnic and the Ngee Ann College; and the basis on which the bursaries will be awarded.
- *18. Enche Abdul Aziz Karim: To ask the Minister for Defence (a) how many Police officers have lost their service weapons from 1st January, 1968, up to the latest convenient date in 1969, and under what circumstances the weapons were lost; (b) how many of the lost weapons have been recovered; and (c) what disciplinary action has been taken against those officers who negligently or carelessly lost their weapons.
- *19. Enche Rahmat bin Kenap: To ask the Minister for Defence whether some Police officers were interrogated in investigations following the arrest and detention of certain persons for activities connected with illegal *Chap Ji Kee* operators, and the number of such officers; and if he will make a statement on the matter.
- *20. Mr. Hwang Soo Jin: To ask the Minister for Defence (a) what is the total number of traffic offences committed by drivers of Singapore military vehicles during the period 1st January to 31st December, 1968;
 (b) whether disciplinary action is taken against the drivers in each case; and (c) whether it has been impressed upon military personnel that they should at all times endeavour to maintain a high standard of road courtesy.
- *21. Enche Rahmat bin Kenap: To ask the Minister for Defence if he is aware that some employees in the private sector who were volunteers in the People's Defence Force were sometimes late for, or even absent from, training because their employers would not grant them time off from work to attend training and because of their frequent absences were dismissed from the Force though they were very keen to continue in the Force; and what steps he has taken or proposes to take in the matter.
- *22. Mr. Ang Nam Piau: To ask the Minister for Social Affairs whether he will consider introducing a scheme for allowances to cancer patients, similar to the T.B. Treatment Allowances Scheme, in view of the increasing number of cancer patients.
- ***23.** Enche Abdul Aziz Karim: To ask the Minister for Law and National Development how many pedestrian overhead bridges have been built to-date and the total cost incurred; and how many such bridges will be built in 1969.

- *24. Mr. Ang Nam Piau: To ask the Minister for Law and National Development whether he is aware that persons intending to use the standard type house plan No. 2A of the Chief Building Surveyor's Department usually make certain alterations to the plan before adopting it; and if steps will be taken to make available a revised plan 2A incorporating the alterations generally made.
- *25. Mr. Yeoh Ghim Seng: To ask the Minister for Health how many refuse disposal plants are operated by his Ministry, and whether there are any plans to erect more of such plants.
- ***26.** Mr. Ho Kah Leong: To ask the Minister for Health if he will consider setting up an ambulance service centre in Jurong Town, in view of the growing population and the increasing number of accidents there.

- 2. Mr. L. P. Rodrigo: To ask the Minister for Health how many births have been recorded by or reported to the Hospital Authorities from 1st January, 1967, up to the latest convenient date
 - (a) in which the child was born with physical or mental abnormalities as to seriously handicap it;
 - (b) in which a pregnancy had been the result of
 - (i) rape or incest;
 - (ii) intercourse with an insane person;
 - (iii) intercourse with a feeble-minded person;
 - (c) which resulted in the death of the pregnant woman as the pregnancy had involved risk to her life;
 - (d) which resulted in physical or mental injury to the pregnant woman as the pregnancy had involved such risk to her.
