QUESTIONS FOR ORAL ANSWER

- *1. Mr. Ang Nam Piau: To ask the Minister for Finance if he will ascertain from the Tourist Promotion Board how many officers of the Board had resigned between 1st January and 31st May, 1969, and the reasons for their resignations; and whether the resignations are likely to have adverse effects upon the administration of the Board, and what steps have been taken in the matter.
- *2. Mr. Ho Kah Leong: To ask the Minister for Finance whether and when directives have been issued for the implementation of the recommendation of the Civil Service Salaries Commission that medical benefits be extended to teaching personnel in Government-aided schools.
- *3. Mr. Ang Nam Piau: To ask the Minister for Foreign Affairs and Minister for Labour if he will furnish the employment figures gathered by the Ministry of Labour from 1st January, 1967, up to the latest convenient date; and whether he is satisfied with the expansion in employment opportunities created by the Government's policy of rapid industrialisation.
- *4. Mr. Hwang Soo Jin: To ask the Minister for Communications (a) whether the existing sealanes leading in and out of the Port of Singapore are adequate to cope with the increasing volume of sea traffic; (b) whether there are sufficient experienced pilots to ensure the safe movements of vessels in Singapore waters; and (c) whether all individual pilots and tugs are now equipped with portable tranceivers.
- *5. Mr. Hwang Soo Jin: To ask the Minister for Communications whether there are adequate facilities to ensure the swift removal of underwater obstructions in the form of sunken hulls in the Singapore Harbour.
- *6. Mr. Hwang Soo Jin: To ask the Minister for Communications if he will make a statement on the reported resignations of some senior officials of the Port of Singapore Authority recently, and whether those resignations are likely to have adverse effects upon the administration of the Authority.
- *7. Mr. Ho Kah Leong: To ask the Minister for Defence what steps the Police are taking to curb excessive speeding by some drivers of earth-carrying lorries in Jurong Town, as such drivers are endangering the lives of other road-users.
- *8. Mr. Ang Nam Piau: To ask the Minister for Law and National Development what use will be made of the portion of land at Sin Min Road which had been cleared of squatters recently.
- *9. Mr. Ho Kah Leong: To ask the Minister for Health what measures are being taken by the Public Health Department against the spilling of earth on the roads from earth-carrying lorries in Jurong Town.
