QUESTIONS FOR ORAL ANSWER

- *1. Dato Abdul Hamid bin Haji Jumat: To ask the Prime Minister what were the total tonnages of cargoes handled by the Singapore Harbour Board during the first quarters of 1959 and 1960 respectively.
- *2. Dato Abdul Hamid bin Haji Jumat: To ask the Prime Minister whether agreement has been reached with the Johore Government with regard to water supplied to Singapore, and what was the total sum claimed by the Johore Government in respect of such supply from January, 1954, to March, 1960.
- *3. Dato Abdul Hamid bin Haji Jumat: To ask the Prime Minister under what circumstances will permits be granted for the retention of unauthorised temporary houses, and whether such permits will be granted to unauthorised temporary houses built after 1st June, 1959.
