QUESTIONS FOR ORAL ANSWER

- *1. Mr. LEE CHOON ENG: To ask the Chief Minister whether he will make a statement on Government policy in respect of the nomination of members to fill vacancies on Trusts or Boards which are within the power of Government to fill.
- *2. Mr. LEE KUAN YEW: To ask the Chief Secretary whether the question of an increase in pensions and cost of living allowance for pensioners has been decided.
- *3. Mr. LEE CHOON ENG: To ask the Chief Secretary whether he will make a statement on the arrest of Mr. Tan Lay Boon, an official of the Army Civil Service Union.
- *4. Mr. Goh Tong Liang: To ask the Attorney-General whether he will consider introducing amending legislation so that convicted opium addicts shall not be committed to prison but sent to anti-opium treatment centres.
- *5. Mr. Lee Choon Eng: To ask the Financial Secretary whether he is satisfied that the extent of personal relief to income taxpayers in the Colony is adequate in the present circumstances.
- *6. Mr. R. C. H. Lim: To ask the Minister for Communications and Works whether, in view of official statements about the negotiation of fresh agreements to take effect next year between Malayan Airways Limited and the Governments of the Borneo territories, the Federation of Malaya and Singapore, he will give an assurance that the text of any new agreement to which the Singapore Government is to be a party will be communicated to the Assembly before it is signed.
- *7. Mr. LIM KOON TECK: To ask the Minister for Communications and Works what steps have been taken to relieve the congestion of the traffic at—
 - (i) the junction of Paya Lebar and Yio Chu Kang Roads; and
 - (ii) the 6th milestone Yio Chu Kang Road.
- *8. Mr. LIM CHER KHENG: To ask the Minister for Education whether he will give details of the 1956–1957 development plan for English schools and Vernacular schools; and whether he has any plan for building a Malay secondary school in the Siglap-Bedok area.
