## QUESTIONS FOR ORAL ANSWER

- \*1. Mr. Yeo Toon Chia: To ask the Minister for Education (a) if he will give figures of Chinese and English relief teachers employed in Government and Government-aided primary and secondary schools in 1970, and from 1st January, 1971, up to the latest convenient date; and (b) if he will consider introducing a training scheme during school holidays for those relief teachers so as to improve their teaching standard and enable them to become fully qualified teachers and take up teaching as a profession.
- \*2. Mr. J. F. Conceicao: To ask the Minister for Culture if he will consider introducing a system of film classification to replace the current system of film censorship.
- \*3. Mr. Ang Nam Piau: To ask the Minister for Law and National Development if he will ascertain from the Housing and Development Board when the Upper Thomson Road Shopping Centre will be ready; and if, in the allocation of shophouses, etc., in the Centre, preference will be given to shopkeepers and residents affected by the widening of Upper Thomson Road and to hawkers living in that Constituency.
- \*4. Mr. Yeo Toon Chia: To ask the Minister for Law and National Development if his Ministry has any plans to utilise the site of the former abattoir at Jalan Besar for the construction of multi-storey residential flats or a shopping and hawker centre so as to provide better amenities for the residents of that area.
- \*5. Enche Abdul Aziz Karim: To ask the Minister for Health (a) whether he considers the unilateral action of the Hawkers Branch of his Ministry in reducing the sizes of the stalls at the Rayman Market and charging the same rental justified, in view of the fact that stallholders at the Market have been and are suffering loss of business ever since their customers who used to stay at Jalan Kebun Limau were evicted; and (b) when and where those stallholders will be re-sited after the Market is demolished and if he will ensure that suitable alternative stalls be found for all the stallholders concerned as a proof of his Ministry's concern in looking after the livelihood of its licensees in the Market.
- \*6. Mr. Ang Nam Piau: To ask the Minister for Home Affairs whether he is aware that there are many foreign hippies in Singapore; and, in view of the bad influence they have on the Republic's youth, if he will take steps to ban their entry into Singapore.
