#### 5 MATTERS REFERRED TO THE COURT

In 2019, the Court heard an application under section 44 of the Act made by SBS Transit Ltd and SBS Transit DTL Pte Ltd for the interpretation of clauses in collective agreements relating to working hours, overtime and rest day. The Court, on its own motion, also examined whether there had been compliance with those clauses. Based on the information provided by the Applicant and the National Transport Workers' Union, the Court was satisfied that they had been fully complied with and were in accordance with the Employment Act (Cap 91).

#### 6 COLLECTIVE AGREEMENTS CERTIFIED BY THE COURT

432 Collective Agreements ("CAs") were filed with the Court in 2019, an increase of 49 CAs over the previous year. Together with the 48 CAs brought forward from 2018, a total of 480 CAs had to be processed and certified. Out of these CAs, 405 were certified by the Court and 14 of them involved public sector employees. At the end of 2019, there were 75 CAs pending certification.

#### 7 VARIATION OF COLLECTIVE AGREEMENTS

In 2019, fifteen variations of CAs were filed with the Court compared to five applications in 2018. Fourteen of them were approved by the Court in 2019. At the end of 2019, there was one variation pending approval.

The Act provides that a CA shall be in force for a period not less than two years or more than three years from the date on which it is expressed to come into force. Of the 432 CAs filed with the Court in 2019, 321 CAs had a duration of three years, 95 had a duration of two years and 16 had a duration of between two and three years.
