NOTICES OF AMENDMENTS TO BILLS

IN COMMITTEE

INSTITUTE OF EDUCATION BILL [Bill No. 35/70]

Clause 4:

Minister for Education:

- (1) **In page 2, lines 17 and 18:** to leave out "the various fields of education for teachers" and insert "education".
- (2) **In page 3, line 2:** to leave out "20" and insert "19".

STATUTE LAW REVISION BILL [Bill No. 36/70]

First Schedule:

Minister for Law and National Development:

- (1) **In page 2, after line 21:** to insert —

"Explosive Substances Ordinance (Chapter 217)	In each of sections 3, 4 and 5, for the word "whipping" there is substituted the word "caning".

- (2) **In page 2, after line 33:** to insert —

"Printing Presses Ordinance (Chapter 226)	In each of sections 6, 19 and 20, for the words "Justice of the Peace" there are substituted the words "person authorized by the Minister in that behalf".

In page 6, after line 33: to insert —

"Chapter 64	Contribution to Imperial Defence Ordinance	The whole."

PRESERVATION OF MONUMENTS BILL [Bill No. 38/70]**Clause 8:**

Minister for Law and National Development:

In page 5, line 30: after "Board", to insert "and that preservation order shall take effect and come into operation on the date of that notification and shall remain in force until revoked by the Minister or until it otherwise ceases to have effect".

Clause 9:

Minister for Law and National Development:

(1) **In page 6, line 4:** to leave out from "withheld)" to the end of line 10 and insert "be demolished, removed, altered or renovated or have any addition made except in case of urgent and immediate necessity for the safety of persons or property."

(2) **In page 6, line 12:** to leave out from "the" to the end of line 13 and insert —

"land which is the site of the monument and shall operate as if it were a charge on land, whether that land is registered or unregistered land. The preservation order shall, —

(a) if it affects registered land, be regarded as a statutory obligation under paragraph (c) of subsection (1) of section 28 of the Land Titles Ordinance, 1956; and

(b) if it affects unregistered land, be regarded as if it were a charge under the Registration of Deeds Ordinance and, upon registration of a memorandum of the charge, created by the preservation order, the charge shall, notwithstanding the provisions of that Ordinance, have priority over all other instruments (including charges and other encumbrances) affecting that land."
