Clause 10:

Clause 1:

Minister for Culture and Social Affairs:

In page 1, line 3: after "National", to insert "Archives and".

Clause 2:

Minister for Culture and Social Affairs:

- (1) In page 1, line 7: after "National", to insert "Archives and".
- (2) In page 1, line 14: after "National", to insert "Archives and".
- (3) In page 2, line 7: to leave out "and".
- (4) In page 2, line 9: at end, to add "and
 - (c) have been transferred to the Centre or to such other place as the Director may from time to time determine:".

- "Prohibition 14. No person shall—
 - (a) without the written permission of the Director take or send out of Singapore any rublic record;
 - (b) write on, mark, inscribe or convise deface any public record; or
 - (c) mutilate, excise or otherwise damage any public record.".
