- 3 Rearrangement of Business (Leader of the House) Motion made, and Question put Resolved, "That, pursuant to Standing Order 10(2), the motion for leave to bring in a Bill by Ms Hazel Poa be taken immediately after the proceedings on the Motions on "Consideration of Matters Regarding Member of Parliament" and "Suspension of Member" have been concluded.".
- 4 Simultaneous Debate on Motions (Leader of the House) Motion made, and Question put Resolved, "That, notwithstanding the Standing Orders, the Motions on "Consideration of Matters Regarding Member of Parliament" and "Suspension of Member" be taken together, and the debate on these Motions and on any amendment proposed thereto be proceeded with simultaneously as though the debate were on a single Motion.".
- 5 Child Development Co-Savings (Amendment) Bill (Minister of State, on behalf of the Minister for Social and Family Development) Question again proposed on the resumption of debate, "That the Bill be now read a second time.".

Bill read a second time and committed to a Committee of the whole House.

- (b) Affirms the need to deal firmly and fairly with any Member of Parliament who is being investigated for possible wrongdoing; and
- (c) Resolves to consider the matter regarding Member of Parliament S Iswaran when the outcome of the ongoing investigations against him is known.".

Suspension of Member – (Ms Hazel Poa) – Motion made, and Question proposed, "That this House suspends Mr S Iswaran from the service of Parliament for the remainder of the current session of the 14th Parliament.".

Pursuant to the earlier resolution for the motions on Consideration of Matters Regarding Member of Parliament and Suspension of Member to be taken together, and the debate on these motions and on any amendment proposed thereto be proceeded with simultaneously as though the debate were on a single motion, the House proceeded to debate the two motions simultaneously upon the Questions being proposed.

Resolved, "That this House:

- (c) Resolves to consider the matter regarding Member of Parliament S Iswaran when the outcome of the ongoing investigations against him is known.".
- 9 Suspension of Member (Ms Hazel Poa) On Question put and negatived.
- 10 Parliament (Privileges, Immunities and Powers) (Amendment) Bill (Ms Hazel Poa) Motion made, "That leave be given to introduce a Bill intituled 'An Act to amend the Parliament (Privileges, Immunities and Powers) Act 1962'.".

Question put, and negatived.

11 Adjournment – (Leader of the House) – Motion made, and Question put – Resolved, "That at its rising today, Parliament do stand adjourned to a date to be fixed.".

12 Adjournment – (Leader of the House) – Motion made, and Question proposed, "That Parliament do now adjourn."; Debate arising.
