- 1 Announcement by Speaker – Mr Speaker made the following communication to the House:-
- "Pursuant to paragraph (7) of Standing Order 92, I have fixed the times for the conclusion of consideration of the heads of expenditure in the Estimates of Expenditure for FY 2018/2019 in the Committee of Supply.
- In fixing these times, I have taken into account the reduction of Question Time to 30 minutes on the days allotted for the COS debates and the extension of sitting times of the Committee of Supply for each of the allotted days.
- Additionally, Members are notified that the sittings on the allotted days of 1 to 8 March will commence at 10.00 am.
- The "guillotine" times I have fixed have been notified to Hon. Members."
- 2 4 Questions for Oral Answer were answered during Question Time.
- 3 Aviation (Miscellaneous Amendments) Bill – "to amend the Air Navigation Act (Chapter 6 of the 2014 Revised Edition) and the Civil Aviation Authority of Singapore Act (Chapter 41 of the 2014 Revised Edition) in relation to the aviation safety framework and aviation industry infrastructure" – President's recommendation signified and Bill presented by the Minister for Transport; read the first time; to be read a second time at a sitting on or after 15 March 2018 and to be printed. [Bill No. 13/2018].
- 4 Criminal Justice Reform Bill – "to amend the Criminal Procedure Code (Chapter 68 of the 2012 Revised Edition) and certain other Acts to enhance the fairness of procedures, and ensure correct and equitable outcomes, in the criminal justice system" – presented by the Senior Minister of State, on behalf of the Minister for Law; read the first time; to be read a second time at a sitting on or after 15 March 2018 and to be printed. [Bill No. 14/2018].
- 5 Evidence (Amendment) Bill – "to amend the Evidence Act (Chapter 97 of the 1997 Revised Edition)" – presented by the Senior Minister of State, on behalf of the Minister for Law; read the first time; to be read a second time at a sitting on or after 15 March 2018 and to be printed. [Bill No. 15/2018].
- 6 Budget Statement – (Minister for Finance) (2nd Allotted Day) – Question again proposed on resumption of Debate on Question (19 February 2018), "That Parliament approves the financial policy of the Government for the financial year 1st April 2018 to 31st March 2019."; Debate resumed.
- 7 Adjournment of Debate – (Leader of the House) – (with the consent of Mr Deputy Speaker) – Motion made, and Question put – Resolved, "That the debate be now adjourned."
